B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland A is located west of a residence and abuts the lake-to-lake trail on the north side of the Review Area. It is a depressional wetland with palustrine forested and scrub-shrub vegetation. Groundwater and precipitation appear to be the primary sources of wetland hydrology. The wetland is depressional, with no outlet, and does not slope in any direction. Wetland A is to the south of Main Street and is separated from the roadside ditch by a trail. The roadside ditch is a shallow (less than 1 foot deep) grassy swale. There are no scour marks, no indication of an ordinary high watermark, and does not exhibit any wetland characteristics (personal communication between K. Tong and N. Lund, The Watershed Company, on 5/2/12). The roadside ditch is not a water of the U.S. Therefore, the nearest water of the U.S. is Wetland C to the east. Wetland A has no direct surface hydrologic connection to Wetland C. The area between Wetland A and C is developed upland areas. There does not appear to be any shallow subsurface connection between Wetland A and C. Wetland A is isolated with no connection to interstate or foreign commerce. Coordination was initiated with USACE Headquarters and EPA on 16 May 2012. No response was received within 21 days.
