Interested parties are hereby notified that the U.S. Army Corps of Engineers (Corps) and the Washington Department of Ecology (Ecology) have received an application to perform work in waters of the U.S. as described below and shown on the enclosed drawings dated November 21, 2016.

The Corps will review the work in accordance with Section 404 of the Clean Water Act (CWA) and Section 10 of the Rivers and Harbors Act. Ecology will review the work pursuant to Section 401 of the CWA, with applicable provisions of State water pollution control laws and the Coastal Zone Management Act.

**LOCATION:** Work is located at adjoining properties at three separate sites along the Shoreline of Puget Island, and one near Cape Horn, in the Columbia River near Cathlamet, Wahkiakum County, Washington.

Sites include:

- 1) River Mile 38.25, Sand Pit - 16 residential parcels would receive up to 366,870 cubic yards (CY) over 21.7 acres
- 2) River Mile 40.0-40.5, North Welcome Slough – 26 parcels would receive up to 1,036,231 million CY over 41.7 acres

- 3) River Mile 43.5, Pancake Point – 26 parcels would receive up to 286,030 CY of material over 17.6 acres
- 4) River Mile 47.5, Cap Horn – 29 parcels would receive up to 492,950 CY of material over 22.9 acres.

**WORK:** Place up to 2,182,080 million CY of clean dredged material (sand) on 104 acres over a period of 10 years.

**PURPOSE:** Protect private property.

**ADDITIONAL INFORMATION:** Discharged material would recreate eroded shorelines and create beach areas below the plane of the ordinary high water. The applicant proposes to use clean dredged material obtained from local dredging projects conducted by the Corps, Portland District.

The proposed sole method for material delivery at the Sand Pit, Welcome Slough and Cape Horn locations is direct delivery with pipeline dredge where material is pumped through a discharge pipeline. In addition to direct delivery, two other possible alternatives for sand placement at Pancake Point are possible. Pipeline delivery from a temporary rehandling area where material is brought in by a vessel, e.g., bottom-dump hopper dredge, and potentially placed in a temporary rehandling area for transferal to the site by pipeline dredge. The other alternative is delivery from a hopper dredge or barge with pump-out capability where material is pumped ashore from a hopper dredge, or similarly a barge fitted with pump-out capabilities may transport the material ashore.

Initial delivery of the material at the Sand Pit site would be to the dewatering area, which is designed for this purpose and includes a return water weir. Due to the existing conditions at the North Welcome Slough site it is not conducive for dewatering. Pancake Point and Cape Horn are currently being evaluated to determine if dewatering is an option given site conditions.

**Disposal Conditions:** The following standard site-use conditions will be specified by the Corps and the Washington Department of Natural Resources as part of the Federal/State permitting processes if a permit is issued: (1) disposal operations must not interfere with Indian treaty fishing at the disposal site, including gill nets and other fishing gear; (2) the permittee must coordinate any nighttime disposal with the Corps, Seattle District, Regulatory Branch Project Manager; and (3) approval must be received from the District Engineer prior to conducting nighttime disposal. Other appropriate special conditions may be added as a result of comments received during the public review period for this public notice.

**MITIGATION:** A mitigation plan was not submitted.

**ENDANGERED SPECIES:** The Endangered Species Act (ESA) requires federal agencies to consult with the National Marine Fisheries Service (NMFS) and/or U.S. Fish and Wildlife Service pursuant to Section 7 of the ESA on all actions that may affect a species listed (or proposed for listing) under the ESA as threatened or endangered or any designated critical habitat. A preliminary determination indicates the activity will affect endangered or threatened species, or their critical habitat. Consultation under Section 7 of the ESA is required.

**ESSENTIAL FISH HABITAT:** The Magnuson-Stevens Fishery Conservation and Management Act, as amended by the Sustainable Fisheries Act of 1996, requires all Federal agencies to consult with the NMFS on all actions, or proposed actions, permitted, funded, or undertaken by the agency, that may adversely affect Essential Fish Habitat (EFH). The proposed action would impact EFH in the project area. The Corps has determined that the proposed action will adversely affect designated EFH for federally managed fisheries in Washington waters. The Corps has initiated EFH consultation with the National Marine Fisheries Service.

**CULTURAL RESOURCES:** The Corps is reviewing the latest published version of the National Register of Historic Places, Washington Information System for Architectural and Archaeological Records Data and other sources of information. The permit area is likely to contain historic properties eligible for inclusion in the National

Register. An investigation for the presence of eligible historic properties is justified. The Corps invites responses to this public notice from Native American Tribes or tribal governments; Federal, State, and local agencies; historical and archeological societies; and other parties likely to have knowledge of or concerns regarding historic properties and sites of religious and cultural significance at or near the project area. After receipt of comments from this public notice, the Corps will evaluate potential impacts and consult with the State Historic Preservation Officer and Native American Tribes in accordance with Section 106 of the National Historic Preservation Act, as appropriate.

**PUBLIC HEARING:** Any person may request, in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Requests for public hearings shall state, with particularity, the reasons for holding a public hearing.

**EVALUATION – CORPS:** The decision whether to issue a permit will be based on an evaluation of the probable impacts, including cumulative impacts, of the proposed activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefits, which reasonably may be expected to accrue from the proposal, must be balanced against its reasonably foreseeable detriments. All factors which may be relevant to the proposal will be considered, including the cumulative effects thereof; among those are conservation, economics, aesthetics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shoreline erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownership, and, in general, the needs and welfare of the people.

The Corps is soliciting comments from the public; Native American Nations or Tribal Governments; Federal, State, and local agencies and officials; and other interested parties in order to consider and evaluate the impacts of this activity. Any comments received will be considered by the Corps to determine whether to issue, modify, condition or deny a permit for the work. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the activity.

The described discharge will be evaluated for compliance with guidelines promulgated by the Environmental Protection Agency under authority of Section 404(b)(1) of the CWA. These guidelines require an alternatives analysis for any proposed discharge of dredged or fill material into waters of the United States.

**EVALUATION – ECOLOGY:** Ecology is soliciting comments from the public; Federal, Native American Nations or Tribal Governments, State, and local agencies and officials; and other interested parties in order to consider and evaluate the impacts of this activity. Ecology will be considering all comments to determine whether to certify or deny certification for the proposed project.

**ADDITIONAL EVALUATION:** This proposal is the subject of a Shorelines Substantial Development Permit which is being processed by Wahkiakum County.

**COMMENT AND REVIEW PERIOD:** Conventional mail or e-mail comments on this public notice will be accepted and made part of the record and will be considered in determining whether authorizing the work would not be contrary to the public interest. In order to be accepted, e-mail comments must originate from the author's e-mail account and must include on the subject line of the e-mail message the permit applicant's name and reference number as shown below. Either conventional mail or e-mail comments must include the permit applicant's name and reference number, as shown below, and the commenter's name, address, and phone number. All comments whether conventional mail or e-mail must reach this office, no later than the expiration date of this public notice to ensure consideration.
