ADDITIONAL INFORMATION SUPPORTING NJD: Site is currently a partially undeveloped lot with fill placed on the western side (in uplands). Surrounding vicinity has been moderately developed for industrial, recreational, and commercial uses. The site is bounded on the west Hannegan Road, by the Hannegan Speedway on the north side, by a commercial development on the south side, and by undeveloped properties on the east side. Wetlands in question are scattered across the property. The 18 acre site is rectangular in shape and trends generally east/west with an unnamed tributary to Squalicum Creek lying in a defined ravine separating the eastern 1/3 of the property from the western 2/3's. Property has been previously manipulated for historic agricultural use. Total acreage of wetlands on site is 1.6 acres; Wetlands C, D, E, and F do not have a surface water connection to other navigable or interstate waters of the U. S or tributaries of waters of the U. S. These wetlands are not used for interstate commerce including recreational activities, commercial fishing activities, or used for industrial purposes. Wetlands A and B are adjacent to an unnamed tributary of Squalicum Creek. These wetlands are jurisdictional.
