Explain: **Wetland A is a depressional wetland with no outlet that lies on a terrace above the large Pierce County stormwater facility on the northwest side of the intersection of 128th South East and 86th East. 100 square feet. This wetland receives and traps surface flow from the surrounding slopes. Soils in the wetland are mapped as pits.

Wetland B is a 5,000 square foot depressional wetland on the Southwest corner of 128th South East and 86th East. Wetland B was created from a piped connection from Rogers High School's stormwater facility overflow, it currently collects flow from the surrounding landscape and has no surface outlet. The stormwater facility system is piped and flows to the southwest where it enters a storm water infiltration pond where there is no outlet. A site visit to the stormwater infiltration pond was conducted. There are 3 pipe openings into the pond. Pierce County has confirmed that none of the 3 culverts provide an outlet. All 3 are inlets to the infiltration pond from the surrounding area. The topography to the North and East of the wetland rises for roads preventing flow in these directions. To the West the topography slopes down into a valley where there is a rise on the other side of the stormwater infiltration pond preventing flow further to the West. To the South there is a rise in elevation preventing flow in this direction. Soils consist of non-hydric Indianola loamy sand.

The nearest documented stream is approximately 2 miles away from both wetlands.

The surrounding area is a suburban neighborhood next to a high school. Wetland B provides an infiltration pond for stormwater. There are no agricultural businesses in the immediate vicinity. The infiltration pond was not flooded during a site visit and there were no structures to remove water. No habitat of special significance or animal species of special significance were present.
