The requirement for relocation would be to:

- 1) Relocation service shall provide boxes with tags to identify personnel, 3 library carts for storage in transition area. Move boxes, computers, telephones, rolling file cabinets (average 2 per person) and transfer file folders to file cabinets, plants into the transition area.
- 2) Move at any time could consist of relocation of 10 personnel to 40 personnel per Phase. There are 7 phases. Below is an anticipated move schedule. This is only estimated and the movers will be contacted within 5 days prior to relocation requirement.
