SCOPE OF WORK FOR ROCK & GRAVEL

1. LOCATION

Truck and trailer, to our Union Slough project, just under Interstate 5, shall deliver materials furnished under this purchase order. North East of the town of Everett and west of Snohomish, next to the sewage treatment plant in Snohomish County, Washington.

2. WORK TO BE DONE

1.5" crushed gravel, delivered, approximately 2000 tons

3 to 8 inch clean spall rock, delivered for slope protection 1500 tons.

Pit Run a well graded impervious material gravel 8,400 tons, delivered.

3. COMMENCEMENT, PROSECUTION AND COMPLETION

It is anticipated that work will be accomplished from 7 June to 18 June 2004.

4. INSPECTION AND SUPERVISION

All work will be conducted under direction of the Emergency Management Branch, Seattle District, Corps of Engineers.

5. SAFETY REQUIREMENTS

Operation of equipment shall be conducted in accordance with the requirements of EM 385-1-1 "Safety and Health Requirements Manual", dated 3 September 1996. All dump trucks are required to have CC permits. Back-up alarms are required for all trucks and bulldozers.

6. MEASUREMENT AND PAYMENT

Payment will be based on a price per ton for delivered.
