STATEMENT OF WORK

1. Background & Objective.

The Integrated Training Area Management (ITAM) program is the Army's comprehensive approach to land management. ITAM is based on the integration of military mission, natural resource stewardship, and environmental compliance. ITAM provides for the maintenance of Army training land in order to ensure quality training and realism, reduce environmental damage, and enhance the public image of the Army as a conscientious land steward. An important component of ITAM is the Land Rehabilitation and Maintenance (LRAM) program, which uses revegetation and preventive and corrective measures to restore the land and enhance the realism of training.

The objective of this Statement of Work (SOW) is to provide supplies for a new greenhouse being built for the ITAM program to the Fort Lewis, Washington, Directorate of Planning, Training, and Mobilization (DPTM)/Range Division.

2. Contractor Services.

a. General Requirements. Excluding the Government-furnished property identified (Section 4.0), the contractor shall furnish to the Ft Lewis location designated by the Seattle District, all services, labor, materials, supplies, and equipment related to and necessary to equip the newly constructed greenhouse. All of the supplies and equipment provided/installed under this statement of work shall be the property of the United States.

b. Specific Requirements.

Benches. Provide and install Over-Easy or similar rolling benches. Ten (10) 5' wide x 8' long benches complete with heavy-duty G-90 galvanizing finish legs set for concrete filled footings with legs set for 6' spacing maximum; aluminum bench side rails (frame pre-punched so cross bars line up with the frame this simplifying installation); each bench supplies with corner protectors (#B9974005) complete with two pop-rivets each; bench tops to be 32" above grade; anti-tip brackets including bolt spacers); galvanized under frame cross bars on 6" spacing angled to prevent soil from collecting on cross bars; galvanized steel bench top cross bars on 2" spacing; provide washered set screws to secure expanded metal to bench frame; ten (10) sheets 5' wide x 8" long ¾ diamond shaped—hot dipped galvanized-steel expanded metal bench tops; and benches designed to withstand 15 lb. per square foot weight maximum.

Greenhouse Supplies. Provide four (4), ¾ inch diameter, 50 foot long **garden hoses**; two (2) **programmable water timers** with up to 6 timed cycles per day, programmable continuous mist cycle for short and frequent watering needs, digital panel display for feedback while programming, easy one touch preset watering programs, and a customizable seven day watering schedule. Shall include built-in solenoid valve that connects to standard 3/4" water hose fittings and use batteries; **nozzle** - miniature version of a professional firefighter's tool, brass, stainless steel, and reinforced nylon construction.

Storage Building. Provide and install Cedar Gardener's Hutch (50"W x 21"D x 70"H. approximately 200 lbs) or similar cedar storage building at the designated location. Include double doors, two shelves. Materials shall be weather and insect-resistant (i.e.; western red cedar).

Benchwarmer. Provide and install TrueLeaf or similar Benchwarmer kit(s). Two (2) benches will require benchwarmers to assist with seedling propagation. Consult with Fort Lewis ITAM personnel on placement of the benchwarmers.

OPTIONAL Miscellaneous Supplies. Provide unit costs for the following optional items;

- 1) 10'x10' wood construction storage shed. Price one each.
- 2) Weather and insect resistant, 6' potting bench with storage area. Price one each

- 3) Water hoses hose hangers to accommodate 1/2" and 3/4" hoses. Price each piece.
- 4) Six (6) foot rolling work bench. Price each.
- 5) Twelve (12) inch deep utility sink. Price each
- 6) Soil tumbler
- 7) Gardening gloves. Price pair.
- 8) Plant labeling tags. Price per bag
- 9) Automatic water timer. Price each.

The Government reserves the right to award any, none or all of the listed optional items in quantities specified at the time of award, at the unit prices submitted.

3. Government-Furnished Equipment, Supplies, Information, and Documents.

a. Fort Lewis shall furnish: access to Fort Lewis and gate and building keys as seen necessary. No other Government furnished equipment will be provided.

4. Deliverables.

a. General. All items purchased under this contract are to be provided with 30 calendar days of award to the location identified, complete, and ready for assembly. All deliverables are and will be resident at Range Control, Ft Lewis WA. All information will be coordinated within the ITAM Office and then submitted to the Government Project Manager for final review.

5. General Requirements.

a. Project Manager. Promptly following award of the task order, the contractor shall designate a Project Manager (PM) who shall be responsible for the scheduled execution of the task order. Changes in PM may be made with a prior approval of the Contracting Officer's Representative (COR). The PM shall have the experience and capability to be responsible for the supervision of work and overall quality and serve as liaison between the contractor and the COR for all work required under this contract.

b. Government Project Manager (GPM). The GPM will be Mr. John Weller, Chief Fort Lewis Range Division, (telephone 253 967-6165) who will provide coordination, supply Government-furnished data and services, provide review comments, confirm decisions, and forward necessary documents. All correspondence and deliverables shall be sent to the GPM.

c. Contracting Officer's Representative (COR). The COR is Mr. David Roden (telephone 206-764-3448). The COR will depend on the GPM to supply the contractor with Government furnished data and services and to forward other necessary documents or equipment. Contract interpretation and associated guidance and direction from the Government shall not be official unless specifically authorized by the COR. The COR will seek timely progress of the work and its satisfactory completion. Copies of all correspondence and deliverable shall be sent to the COR.

d. Payment. Payment shall be made in accordance with the payment clause of this contract. A copy of each payment voucher shall be submitted by the contractor to the COR. Final payment will be made upon submittal and installation of all deliverables and return of Government-furnished properties.

e. Billing Procedures. The contractor shall furnish invoices (original) as required to Seattle District, Corps of Engineers, with copies to Fort Lewis, in accordance with the progress schedule, evidencing performance of work done under this task order. The GPM and COR will review the invoice and the COR will forward it to the Corps' contracting office who will forward acceptances to CEFC-ASO-P. Invoices shall be submitted as follows:

f. Extra Services. The contractor is advised not to perform any service under this statement of work, requested by any persons in the Seattle District offices verbally or in writing, which he/she considered to be an adjustment in the work scope requiring a change in contract prices, until the contractor has made a proposal to the GPM covering such extra services, negotiated a mutually satisfactory fee, and received formal notices to proceed.

g. Responsibility for Corrected Document. The contractor is responsible for the completed and corrected work. Corrections and clarifications shall be made by the contractor if found necessary by the GPM during review. Work required for correction or clarification shall be completed and resubmitted within an equitable period of time specified by the GPM.

h. Publication. Prior approval of the GPM is required for any report, based on this task order, prepared for publication by the Contractor. The GPM must approve any oral presentations, which relate to this contract prior to the presentation.

i. Disposition of Materials. All material and documents obtained as a result of this SOW shall become the property of the United States Government.

6. Schedule.

a. The contractor will furnish sufficient technical, supervisory and administrative personnel to ensure completion of work in accordance with the progress schedule below.

b. The consultant shall keep GPM and COR fully advised at all times concerning delays or difficulties that may prohibit completion of any part of the work by the established dates. The schedule is subject to adjustment by modification to the task order, signed by the COR, for material delays on the part of the Government and conditions beyond the control of the parties.

c. The work shall be completed within forty-five (45) Calendar days from the Contract Award date.

(a) If an item in this solicitation is identified as "brand name or equal," the purchase description reflects the characteristics and level of quality that will satisfy the Government's needs. The salient physical, functional, or performance characteristics that "equal" products must meet are specified in the solicitation.

(b) To be considered for award, offers of "equal" products, including "equal" products of the brand name manufacturer, must--

(1) Meet the salient physical, functional, or performance characteristic specified in this solicitation;

(2) Clearly identify the item by--

(i) Brand name, if any; and

(ii) Make or model number;

(3) Include descriptive literature such as illustrations, drawings, or a clear reference to previously furnished descriptive data or information available to the Contracting Officer; and

(4) Clearly describe any modifications the offeror plans to make in a product to make it conform to the solicitation requirements. Mark any descriptive material to clearly show the modifications.

(c) The Contracting Officer will evaluate "equal" products on the basis of information furnished by the offeror or identified in the offer and reasonably available to the Contracting Officer. (a) North American Industry Classification System (NAICS) code and small business size standard. The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). (b) Submission of offers. Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation.  - (9) Acknowledgment of Solicitation Amendments;
 - (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
 - (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.
- (c) Period for acceptance of offers. The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.
- (d) Product samples. When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.
- (e) Multiple offers. Offerors are encouraged to submit multiple offers presenting alternative terms and conditions or commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.
- (f) Late submissions, modifications, revisions, and withdrawals of offers:
- (1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.
 - (2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and--

- (A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or
- (B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or
- (C) If this solicitation is a request for proposals, it was the only proposal received.
- (ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.
