June 28, 2004**

1. LOCATION

Services furnished under this contract shall be provided in Mt Vernon, Washington at various sites along the Skagit River.

2. WORK TO BE DONE

Work to be completed shall consist of, being the on site contract construction representative building new levees, and augmenting existing roads from the PL84-99 rehabilitation work along the Skagit River.

The Contract Construction Representative will have to have the following knowledge, skills and abilities:

- a. Past work with the Corps of Engineers on levee rehabilitation and/or show that you have the construction experience to do levee work required to do the job.
- b. Knowledge of survey and be able to do project layout for the project to include dirt work with slopes then rock work with toes and slopes using spall rock and riprap.
- c. Knowledge of daily reports for construction.
- d. Knowledge of Corps of Engineers individual, contractor, equipment time cards for hours worked.

- e. Knowledge of construction equipment and how it is used in construction and be able to direct and manage equipment operators to complete tasks.
- f. Have a Corps of Engineers Boat Operators License or a Coast Guard License for the operation of the Corps of Engineers jet boat. This for inspection of the Union Slough Levee.
- g. Must supply own vehicle that is suitable for work on the construction site.
- h. Because of long hours associated with construction, inspector will have to stay close to the site on per-diem.

### 3. COMMENCEMENT: PROSECUTION AND COMPLETION

It is anticipated that work will begin on or about July 14, 2004 and completed on or before September 30, 2004. Average workweek shall consist of six (6) days. Workday shall begin at approximately 0600 and end at 1800.

### 4. CONSTRUCTION: INSPECTION AND SUPERVISION

All work will be conducted under direction of the Emergency Management Branch, Seattle District Corps of Engineers; Eric Winters cell (206) 909-7951 or office (206) 764-3406.

The Contract Construction inspector will supervise all other contractors that work on the Union Slough site and report to Eric Winters from the Corps of Engineers Emergency Management Branch.

### 5. SAFETY REQUIREMENTS

Operation of equipment shall be conducted in accordance with the requirements of EM 385-1-1 "Safety and Health Requirements Manual", dated 3 November 2003.

### 6. MEASUREMENT AND PAYMENT

#### (a) Measurement

For the purpose of calculating payrolls, the workweek is based on seven (7) consecutive days, beginning at 0001 hours (0:01 AM) Monday and ending at 2400 hours (12:00 midnight) Sunday. This workweek shall remain fixed throughout the performance period of this contract. Overtime will be paid for work performed under this contract in excess of 40 hours per driver/operator within a workweek.

#### (b) Payment

Hourly Payment: Hourly Payment will be made based on the number of hours worked, private vehicle usage and per-diem.

- a. Regular time is estimated at 520 hours
- b. Overtime hours are estimated at 416 hours.

## Successor Contracting Officers (52.201-4001)

The Contracting Officer who signed this contract is the primary Contracting Officer for the contract. Nevertheless, any Contracting Officer assigned to the Seattle District and acting within his/her authority may take formal action on this contract when a contract action needs to be taken and the primary Contracting Officer is unavailable.
