**ADDITIONAL INFORMATION SUPPORTING NJD:** Site is currently undeveloped shrub/scrub/forest land. Wetlands in question (Designated Wetland A and Wetland B) occupy areas in the southwest and northeast portions of the property. Surrounding vicinity is composed of a series of forested, hilly terrain used for recreational purposes (part of Odlin County Park). The site is bounded on the northeast by Odlin Park Road and by undeveloped woodlands on all other sides. The 1-acre site is roughly rectangular in shape and slopes down toward the west. Total acreage of wetlands on site is 0.23 acres; 0.10 of an acre will be filled by proposed development.

Wetlands in question do not have a surface water connection to other navigable or interstate waters of the U. S or tributaries of waters of the U. S. Wetlands are not used for interstate commerce including recreational activities, commercial fishing activities, or used for industrial purposes.
