ADDITIONAL INFORMATION SUPPORTING NJD: Site is currently semi-developed with houses and outbuildings (sheds, garages, etc.) in the northeast and northwest portions. Remainder of site is undeveloped. Surrounding vicinity has been extensively developed for residential and commercial use. The 6.5-acre site is roughly rectangular in shape trending north-south with a pronounced, depression at the central and southern portions. Property has been previously manipulated (mowed, etc.) for historic agricultural use (fodder grasses and grazing). The riparian area for Spring Creek crosses the northwest corner of the property and is set in a steep ravine. Wetlands in question are located just south of the central portion of the property. Total acreage of wetlands on site is 0.19 of an acre; 0.19 of an acre will be filled by proposed development.

Wetland in question does not have a surface water connection to other navigable or interstate waters of the U. S or tributaries of waters of the U. S. Wetland is not used for interstate commerce including recreational activities, commercial fishing activities, or used for industrial purposes.
