Paragraph 1 – Project area contains 6 wetlands all of which are contained on site. This is a jurisdictional determination only. No work has been proposed to date.

Paragraph 2-3 – The isolated wetlands are bordered on all sides by uplands and have no connections to a water of the U.S. by any streams, ditches, other wetlands, pipes, or upland swales.

Paragraph 4. – Four jurisdictional wetlands, totally 8.62 acres occur onsite. The JD is an approved JD.
