















The vertical extent of the APE consists of the depth of anticipated ground disturbance and the horizontal extent is the project boundaries. The total project area is approximately 19 acres in size.

We would like to summarize efforts taken to date to identify cultural resources within the APE. The Corps staff archaeologist has conducted a records search and literature review of the Washington Information System Architectural and Archaeological Records Database. The search revealed that there are no previously recorded cultural resources located within or adjacent to the APE. Nor has any previous cultural resource surveys been conducted within the APE of the project. The closest cultural resource survey was conducted in January of 2019 and is directly adjacent to the APE. The

































The Corps previously consulted with your office on this undertaking on 9 Dec 2019 (DAHP Log: 2019-06-04181), defining the area of potential effect (APE). Your office concurred with our definition on 11 June 2019. Since then, additional access and staging areas have been identified as part of the design process, necessitating revision to the previously defined APE. This letter provides an update to the proposed work and modifies the APE under Section 106 as provided at 36 CFR 800.4(a). We request your agreement with the revised APE.

The project area is located in Section 32, Township 27 North, Range 4 East within Ballinger Park, City of Mountlake Terrace, Snohomish County, Washington. The proposed ecosystem restoration at Ballinger Park would include: wetland restoration to improve habitat, reconnect and restore native riparian and floodplain habitats, improve the quantity and quality of existing ponds in the area and removal of non-native riparian vegetation and re-vegetation with native species.

The Corps has determined the APE to include the project's construction footprint and all access roads and staging areas. The total revised APE is approximately 28 acres, incorporating nine additional acres for staging and access (Enclosure 2). Hall Creek runs north to south through the middle of the APE limiting vehicle access west of the creek. West of Hall Creek, access will be off 74<sup>th</sup> Ave W, while access east of Hall Creek will be from the Mountlake Terrace Community Senior Center.

The Corps previously consulted with the Muckleshoot Indian Tribe, Tulalip Tribes, Suquamish Tribe, Snoqualmie Indian Tribe, Sauk-Suiattle Indian Tribe, Swinomish Tribal Community, Stillaguamish Tribe and the Confederated Tribes and Bands of the Yakama Nation of the undertaking on 10 June 2019. No responses were received.

Concurrently with this letter we are notifying the aforementioned tribes of the revised APE to identify properties to which they may attach religious or cultural significance or concerns with historic properties that may be affected.

The Corps requests your review and agreement with our determination of the revised APE. 



The U.S. Army Corps of Engineers (Corps) is currently preparing an integrated feasibility and environmental assessment for proposed ecosystem restoration at Ballinger Lake Park in the City of Mountlake Terrace, WA (Enclosure 1). In our letter dated 10 June 2019, the Corps documented the area of potential effect (APE) with which your office agreed on 11 June 2019. The APE was later amended on 17 January 2020 which your office agreed on 21 January 2020. This letter provides a brief project description, summarizes the efforts taken to identify historic properties, and provides agency findings and determinations as provided at 36 C.F.R. § 800.4 and 5. We request your agreement with our finding of no historic properties affected for the proposed undertaking.

Ballinger Lake Park is a recreational park which includes a tennis court, soccer field, open manicured lawn, and a former golf course. Proposed work for the Lake Ballinger Aquatic Ecosystem Restoration Project at Ballinger Lake Park includes: wetland restoration to improve habitat, reconnect and restore native riparian and floodplain habitats, improve the quantity and quality of existing ponds in the area and remove non-native riparian vegetation and re-vegetate with native species.

The undertaking is located in Section 32, Township 27 North, Range 4 East within Ballinger Lake Park, City of Mountlake Terrace, Snohomish County, Washington. The Corps has determined the APE to include the project's construction footprint and all access roads and staging areas totaling 28 acres (Figure 1).





Figure 2: Cultural Resources Assessment Results LAKE BALLINGER RESTORATION - Subsurface Testing

We would like to summarize efforts taken to date to identify cultural resources within the APE. The Corps staff archaeologist conducted a records search and literature review of the Washington Information System Architectural and Archaeological Records Database. The search revealed there are no previously recorded cultural resources located within or adjacent to the APE; nor has any previous cultural resource investigation been conducted within the APE. One cultural resource inventory was conducted directly adjacent to the APE within the

boundaries of Ballinger Lake Park by ASM Affiliates in January of 2019 (Osiensky & Iversen 2019). As a result of their investigation, no cultural resources were identified. On 23 and 24 July 2019, the Corps conducted pedestrian survey and subsurface testing in the form of shovel probes. A total of 31 shovel probes and one auger probe were placed within the APE Figure 2. As a result of the inventory, one prehistoric lithic scatter, site LB-1, was identified within SP-27 (Figure 3). Site LB-1 consists of eight tertiary flakes of the same low silica possible basalt material. Subsequent radial shovel probes returned negative for cultural materials and no other cultural resources were identified within the APE as a result of the investigation. Due to the presence of cultural materials in SP-27 Corps archaeologists monitored geotechnical boring within the APE on 21, 22, & 23 October 2019 (Figure 4). No cultural materials were observed. Later the APE was amended to include nine (9) acres west of Hall Creek to account for access and a staging area. On 12 February 2020, Corps archaeologist conducted pedestrian survey of the nine acres west of Hall Creek. No cultural materials were observed. Attached is a cultural resources inventory report for the Lake Ballinger project (Bertolani & Kanaby 2020).

The Muckleshoot Indian Tribe, The Tulalip Tribes, Suquamish Tribe, Snoqualmie Indian Tribe, Sauk-Suiattle Indian Tribe, Swinomish Indian Tribal Community, Stillaguamish Tribe of Indians, and the Confederated Tribes and Bands of the Yakama Nation have been notified about the project to identify properties to which they may attach religious or cultural significance or other concerns with historic properties that may be affected. The Tribes did not comment on the undertaking.

The Corps has made a reasonable and good faith effort to identify historic properties that may be affected by this undertaking. Project design will change such that site LB-1 is avoided by all proposed work. No staging or ground disturbance will occur within a five meter buffer of the site. It is further recommended site LB-1 be determined not eligible for inclusion on the NRHP. The Corps has applied the National Register of Historic Places (NRHP) evaluation criteria. Due to the lack of diagnostic artifacts, lack of contextual information, and the disturbed context of the surrounding area evident from the subsurface investigation, site LB-1 is not likely to yield information important to history or prehistory; it is not associated with events that have made a significant contribution to the broad patterns of our history; nor is it associated with the lives of persons significant in our past. Further, site LB-1 does not represent the work of a master or possess high artistic values. Based on this information and the extensive cultural modification of the APE due to the creation of Ballinger Lake Park, the Corps recommends site LB-1 be determined not eligible for listing on the NRHP; further, site LB-1 will be avoided by all proposed work. As a result, the Corps has made a determination of no historic properties affected by the proposed Lake Ballinger Aquatic Ecosystem Restoration project.

The Corps requests your review and agreement with our finding of no historic properties affected. Figure 1: Ballinger Lake Park Vicinity Map
