SUBJECT: Albeni Falls Dam, Special Restrictions for Public Use Areas

1. Reference Title 36 Code of Federal Regulations, Chapter III, Section 327.12 (a), Restrictions

2. Policy. In order to assure the public's safety and protection of historic and natural resources, the following 'Restrictions' apply to Albeni Falls Dam and will remain in effect year round.

a. Recreation area gates are locked from 10 PM to 7 AM. Vehicles shall not enter or leave the area when gates are locked except in an emergency.

b. All motorized vehicles, except those used by disabled or Government, must be licensed for use on county roads and shall not be operated off designated roads.

c. Campers must be ready to occupy a campsite by setting up a sleeping unit when they arrive at the park. Campsite maximums are: 8 people, 2 vehicles consisting of 1 motorized recreational vehicle or 1 vehicle with camp trailer and 1 non-camping vehicle, and 2 tents. Extra vehicles must be parked in a designated lot and will be charged the posted extra vehicle fee. (*Riley Creek may have as many tents as will fit in the impact area.)

d. Fees associated with camping must be paid by the registered occupant of the campsite who is age 18 or over.

e. A campsite being paid for with the use of a pass (America the Beautiful or Golden Passport) must be occupied overnight by the owner of that pass. Registering for a site and having others occupy the site is prohibited.

f. All camping equipment must be located within the campsite impact area. At campsites where the impact area is undefined, equipment must be located near (10 - 15 feet) the fire ring and off vegetation. Moving a picnic table off the impact area of the designated campsite is prohibited.

g. Campground facilities are to be used by registered campers and their visitors only; however, day users <u>are</u> permitted use of campground shower facilities at

Springy Point and Albeni Cove and must park in day use parking areas. The use of campsites for day use is prohibited.

h. Checkout time is 2 PM. Campsites remaining occupied after the checkout time will be assessed camping fees for an additional night of camping.

i. Liquid propane gas campfires shall be located in or touching a fire ring.

j. No more than one line (hammock, clothes, slack, etc.) shall be attached to a tree and shall be adjacent (within 5 feet) to the campsite. No other equipment shall be attached to vegetation. The use of "lines" in day use areas is prohibited.

k. Boat ramp docks are to be utilized solely for loading and unloading. Boats may tie up at docks for 30 minutes maximum. Mooring at docks from 10 PM to 7 AM is limited to registered campers.

I. Hunting and trapping is prohibited within the boundaries of the developed recreation areas. Boundaries are generally defined by fence lines or marked property lines. Maps can be obtained at Albeni Falls Dam or by telephone (208) 437-3133.

m. The discharge of firearms¹, projectile firing devices, bows and arrows, crossbows or other weapons is prohibited unless:

1) Being used by a Federal, State or local law enforcement officer within the scope of their duties;

2) Being used for hunting or fishing as permitted under 36 CFR 327.8; or

3) Being used at authorized shooting ranges.

3. The preceding restrictions are posted at all recreation areas where applicable and are enforced under the Title 36 of the Code of Federal Regulations, Chapter III, Section 327.12 (a) Restrictions.

1 At this time the U.S. Army Corps of Engineers in Idaho is not enforcing the prohibition in 36 C.F.R. Part 327 .13 (a) POSSESSION of loaded firearms, ammunition, loaded projectile firing devices, bows and arrows, crossbows or other weapons. The DISCHARGE of firearms, projectile firing devices, bows and arrows, crossbows or other weapons, however, is prohibited on Corps managed Federal lands or waters unless as specified above.
