Elevation of established OHWM (if known): The tidal station used for reference was the Bangor Wharf where the tidal height for mean high water (MHW) is 10.18-feet (MLLW) and mean higher high water (MHHW) is 11.07-feet (MLLW). Using the program Vdatum, at the project site, MHW is 10.58-feet and MHHW is 11.50-feet. During the visit, five survey sites were chosen for determination of tidal elevations, in relation to the proposed activities. The sampled sites confirms the surveyed elevations of MHW and MHHW shown on project drawings provided by the applicant.
