to other wetlands in the Review Area or a water of the U.S. In addition, there is no use of these wetlands by interstate or foreign travelers for recreational purposes, there is a lack of fish, shellfish, agriculture and silviculture in these wetlands which could be taken or sold in interstate or foreign commerce. Therefore, because there is no interstate commere connection for these hydrologically isolated waters, these wetlands are not waters of the U.S.

Per information submitted by the applicant, Wetlands C, H, I, N, U, X, Z and ZZ were created "water features" as aesthetic features of the original construction of the golf course and property development in the late 1970s. Per NRCS soil maps and information from the consultant, these "water features" were dug in non-hydric soils. The preamble of the 1986 U.S. Army Corps of Engineers (Corps) implementing regulations states that certain waters are generally not considered waters of the U.S. which includes category (d) artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons. In addition to these aesthetic water features being constructed in dryland, these water features are hydrologically isolated (no inlets or outlets to waters of the U.S.) and are not impoundments of a tributary to a water of the U.S. Therefore, these "water features" are not waters of the U.S. per the 1986 preamble of the Corps implementing regulations .
