MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 NWS-2024-6232

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

- 3. REVIEW AREA. The 14.3 acre review area is located at Mill Creek, Snohomish County, Washington (47.8739, -122.2194). The review area consists primarily of undeveloped upland forest. The central western portion of the review area is used as a storage yard and overflow parking. Four wetlands were identified in the review area. The review area is bounded by North Creek Drive to the west, undeveloped forest to the north, Bothell-Everett Highway to the east, and a baseball field to the south.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), THE TERRITORIAL SEAS, OR INTERSTATE WATER TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The Puget Sound, approximately 5 miles west. The Puget Sound is

listed on the Navigable Waters of the United States in Washington State dated December 31, 2008.6

⁶ This MFR should not be used to complete a new stand-alone TNW determination. A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

⁷ 33 CFR 329.9(a) A waterbody which was navigable in its natural or improved state, or which was susceptible of reasonable improvement (as discussed in § 329.8(b) of this part) retains its character as "navigable in law" even though it is not presently used for commerce, or is presently incapable of such use because of changed conditions or the presence of obstructions.

Wetland 1: Wetland 1 is an approximately 0.2 acre palustrine forested depressional wetland in the northeastern portion of the review area. Wetland 1 does not have an outlet. Wetland 1 does not abut an (a)(1), (a)(2) or (a)(3) water. Therefore, Wetland 1 does not have a continuous surface connection to an (a)(1), (a)(2), or (a)(3) waters and is not a water of the U.S.

Wetland 2: Wetland 2 is an approximately 0.5 acre palustrine forested depressional wetland in the central portion of the review area. Wetland 2 does not have an outlet. Wetland 2 does not abut an (a)(1), (a)(2) or (a)(3) water. Therefore, Wetland 2 does not have a continuous surface connection to an (a)(1), (a)(2), or (a)(3) waters and is not a water of the U.S.

Wetland 4: Wetland 4 is an approximately 0.05 acre palustrine forested depressional wetland in the northwestern portion of the review area. Wetland 4 does not have an outlet. Wetland 4 does not abut an (a)(1), (a)(2) or (a)(3) water.

Therefore, Wetland 4 does not have a continuous surface connection to an (a)(1), (a)(2), or (a)(3) waters and is not a water of the U.S.


Wetland 5: Wetland 5 is an approximately 0.01 acre palustrine forested depressional wetland in the western portion of the review area. Wetland 5 does not have an outlet. Wetland 5 does not abut an (a)(1), (a)(2) or (a)(3) water. Therefore, Wetland 5 does not have a continuous surface connection to an (a)(1), (a)(2), or (a)(3) waters and is not a water of the U.S.





FIGURE 2: LOCAL VICINITY MAP CITY OF MILL CREEK - DRCC PROPERTIES PORTION OF SECTION 31, TOWNSHIP 28N, RANGE 05 E, W.M.





FIGURE 3: WETLAND DELINEATION MAP CITY OF MILL CREEK - DRCC PROPERTIES PORTION OF SECTION 31, TOWNSHIP 28N, RANGE 05 E, W.M.
