<u>ANNOUNCEMENT</u>: Full Implementation of the Paperless Initiative at the Seattle District, U.S. Army Corps of Engineers, Regulatory Branch

In an effort to streamline processes and reduce paper waste, the U.S. Army Corps of Engineers, Seattle District, Regulatory Branch (Corps) will be requiring electronic submission of permit applications and documents. We have been implementing this initiative in Phases. Phase I included accepting electronic submission of permit applications from the Washington State Department of Transportation and Water Resources Development Act entities only. During Phase II, we accepted applications from certain counties.

This Special Public Notice announces the full implementation of the Paperless Initiative for all applications for work in waters of the U.S. throughout the entire State of Washington effective January 1, 2020.

If you will be submitting an application for work in waters of the U.S. within Washington State, please see the attached document which details the format for electronic submission of materials. Effective January 1, 2020, please start submitting permit application materials and other subsequent documents electronically following this format.

Also, find attached instructions regarding electronic submittal of compliance documents. After you receive a permit verification from the Corps, there are often permit requirement(s) to submit compliance documents to ensure you have complied with all permit requirements. Typical compliance documents include Certificate of Compliance, As-Built Reports, Mitigation Monitoring Reports, and Cultural Resources Reports.

Instructions for Submitting Electronic Requests (Permit Applications, Permit Modifications, Jurisdictional Requests) to the Seattle District, U.S. Army Corps of Engineers Regulatory Branch December 23, 2019

Content format of requests:

- The preferred document file format is PDF. We will also accept Word documents in .docx format. Any spreadsheets data (i.e., Mitigation Calculator, adjacent property mailing labels, Aquatic Resource/Consolidated Upload Excel spreadsheet) must be submitted in .xlsx spreadsheet format.
- 2. Reduce electronic file sizes to the maximum extent possible.
- 3. If transmitting via email, avoid transmitting information in the body of the email.
- All documents (cover letter, aquatic resource delineations, permit application, endangered species, biological assessment, historic properties reports, etc.) must be submitted <u>as separate file attachments</u>. Do <u>not</u> combine all documents into one Adobe PDF or Word document file.
- 5. Name files based on their content. Please do not use company project numbers or acronyms as the sole basis for the file name(s). While not required, we prefer that the documents use the following naming conventions:

Submitting requests:

There are multiple options for submitting your request and PDF documents to the Corps (in order of preference):

1. Email. Our preferred method of electronic file submittal is via email. Initial requests that have not been assigned a project manager and Corps Reference number should be sent to the Corps application email inbox:

NWS-PermitApp@usace.army.mil

- Do <u>NOT</u> send initial application requests directly to the Project Manager. If you do, they will be returned to you and you must submit them to the above email address.
- Once a project has been assigned, subsequent information should be emailed directly to the Corps Project Manager.

The Corps file limit is 40 MB for individual emails. If your email would exceed 40 MB you can use one of the following methods as a work-around:

- Use .zip files as attachments. Combine multiple files into a .zip file to compress file size prior to adding as an email attachment.
- **Send multiple emails.** Label each email with same subject line and indicate number of emails. For example:

Smith, Jane (wetland fill for a subdivision) Application (1 of 2 emails) Smith, Jane (wetland fill for a subdivision) Application (2 of 2 emails)

2. If an individual document would exceed 40 MB:

- Mail a CD/DVD with all required information. Include a hard copy cover letter briefly stating your request and listing the contents on the CD. <u>DO</u> <u>NOT SEND A USB STICK</u>. The Corps cannot download data from USB sticks.
- Request access to the Department of Defense FTP website. Send an email to NWS-PermitApp@usace.army.mil requesting an access code. Once code is received, follow directions on website to submit application documents. In the "Short Note to the Recipient" box, enter: Permit Application materials for NAME OF APPLICANT.
- Send an email with a link to the documents on your company secure FTP site. The Corps cannot access public ftp sites like Dropbox. Often due to security protocols we cannot access certain FTP sites. If this occurs, use one of the alternate methods of submittal.

Instructions for Submitting Compliance Documents

Content format of compliance document submittals:

- 1. The preferred document file format is PDF.

- 4. All documents must be submitted <u>as separate file attachments</u>. Do <u>not</u> combine all documents into one Adobe PDF or Word document file.
- 5. Name files based on their content. Please do not use company project numbers or acronyms as the sole basis for the file name(s). While not required, we prefer that the documents use the following naming conventions:

- 5. If an <u>individual document</u> would exceed 40 MB:
 - Mail a CD/DVD with all required information. Include a hard copy cover letter briefly stating your request and listing the contents on the CD. <u>DO</u> <u>NOT SEND A USB STICK</u>. The Corps cannot download data from USB sticks.
 - Send an email with a link to the documents on your company secure FTP site. The Corps cannot access public ftp sites like Dropbox. Often due to security protocols we cannot access certain FTP sites. If this occurs, use one of the alternate methods of submittal.
