The Corps will review the work in accordance with Section 404 of the Clean Water Act (CWA) and Section 10 of the Rivers and Harbors Act.

LOCATION: Approximately 220.25 acres within 12 distinct parcels in Willapa Bay near Oysterville, Pacific County, Washington on privately owned property assigned a shellfish farming use designation. The parcel numbers are: 79005000179, 79005000216, 79005000098, 79005000110, 79005000219, 79005000153, 79005000164, 79005000182, 79005000230, 79005000210, 79005000195, and 79005000101. The approximate latitude/longitude coordinates for the center of the site are 46.552274° /-123.995162°, and the project corners are indicated on the project plans.

WORK: This project proposes to continue the commercial cultivation of Pacific oysters within a 220.25-acre cultivation area spread across 12 parcels. Oysters would be cultivated using two techniques: on-bottom and natural catch. For on-bottom cultivation, approximately 134.34 acres of the cultivation area located between the +1 foot and 0 foot Mean Lower Low Water (MLLW) would be seeded with oysters dispersed from a boat at high tide. For natural catch cultivation, approximately 85.91 acres of the cultivation area located between the +1 foot and 0 foot MLLW would receive cleaned and washed spent shell dispersed from a boat at high tide. The discharge of the spent, clean, and washed shell would be less than one inch placed upon 85.91 acres up to once annually. Harrowing of the site would occur periodically depending on substrate conditions. Market-sized oysters would be harvested either by hand at low tide or by mechanical dredge at high tide. Harvesting would occur approximately 2-3 years after seeding.

Access to the site will be exclusively by boat.

PURPOSE: Cultivation of shellfish for commercial sale and human consumption

ADDITIONAL INFORMATION: The applicant has requested that the project be authorized for 12 years.

The location of the line of mean high water and high tide line shown on the project drawings have not yet been verified by the U.S. Army Corps of Engineers (Corps). If the Corps determines the boundaries of the wetland/waters are substantially inaccurate a new public notice may be published.

MITIGATION: Compensatory mitigation has not been proposed for this project.

CULTURAL RESOURCES: The Corps has reviewed the latest published version of the National Register of Historic Places, Washington Information System for Architectural and Archaeological Records Data and other sources of information. There are no recorded historic properties within the permit area. The permit area has been so extensively disturbed by modern development that little likelihood exists for the proposed project to impinge upon an undisturbed historic property. The Corps invites responses to this public notice from Native American Tribes or tribal governments; Federal, State, and local agencies; historical and archeological societies; and other parties likely to have knowledge of or concerns regarding historic properties and sites of religious and cultural significance at or near the project area. After receipt of comments from this public notice, the Corps will evaluate potential impacts and consult with the State Historic Preservation Officer and Native American Tribes in accordance with Section 106 of the National Historic Preservation Act, as appropriate.

ENDANGERED SPECIES: The Endangered Species Act (ESA) requires federal agencies to consult with the National Marine Fisheries Service (NMFS) and U.S. Fish and Wildlife Service (USFWS) pursuant to Section 7 of the ESA on all actions that may affect a species listed (or proposed for listing) under the ESA as threatened or endangered or any designated critical habitat.

The Corps is assessing the potential impacts to listed species and critical habitat in the project area for consistency with the Programmatic Biological Opinions for Shellfish Activities in Washington State Inland Marine Waters (U.S. Fish and Wildlife Service (USFWS) Reference Number 01EWF00-2016-F-0121, National Marine Fisheries Service (NMFS) Reference Number WCR-2014-1502).

ESSENTIAL FISH HABITAT: The Magnuson-Stevens Fishery Conservation and Management Act, as amended by the Sustainable Fisheries Act of 1996, requires all Federal agencies to consult with the NMFS on all actions, or proposed actions, permitted, funded, or undertaken by the agency, that may adversely affect Essential Fish Habitat (EFH).

The Corps is assessing potential impacts to Essential Fish Habitat in the project area for consistency with the with the Programmatic Biological Opinion for Shellfish Activities in Washington State Inland Marine Waters (National Marine Fisheries Service (NMFS) Reference Number WCR-2014-1502).

PUBLIC HEARING: Any person may request, in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Requests for public hearings shall state, with particularity, the reasons for holding a public hearing.

EVALUATION: The decision whether to issue a permit will be based on an evaluation of the probable impacts, including cumulative impacts, of the proposed activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefits, which reasonably may be expected

to accrue from the proposal, must be balanced against its reasonably foreseeable detriments. All factors which may be relevant to the proposal will be considered, including the cumulative effects thereof; among those are conservation, economics, aesthetics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shoreline erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownership, and, in general, the needs and welfare of the people. The Washington Department of Ecology has or will evaluate the proposed project in accordance with Section 401 of the CWA and for consistency with the Coastal Zone Management Act.

The U.S. Army Corps of Engineers is soliciting comments from the public; Native American Nations or tribal governments; Federal, State, and local agencies and officials; and other interested parties in order to consider and evaluate the impacts of this activity. Any comments received will be considered by the Corps to determine whether to issue, modify, condition or deny a permit for the work. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the activity.





Driving Directions: A vessel/boat is requiring to reach intertidal ground


